## COST OF PLAN SERVICES

There are three categories of services provided to your plan:

### 1. GENERAL ADMINISTRATIVE SERVICES

General administrative services include recordkeeping, legal, accounting, consulting, investment advisory and other plan administration services. Some of the expenses for general administrative services are fixed and other expenses such as legal or accounting may vary from year to year. These costs are allocated to each participant in a uniform way.

A TIAA Plan Services Fee, an annual service fee of 0.15%, is charged based upon your account balance, and deducted on a quarterly basis. This applies to plan(s): 406586, 408337

Your Plan provides credits to certain investments so that plan participants share equally in the cost of your Plan's record keeping and other plan services. ### 2. SPECIFIC INVESTMENT SERVICES

## Part B. Annuity Information

The information below focuses on the annuity options under the plan.
